

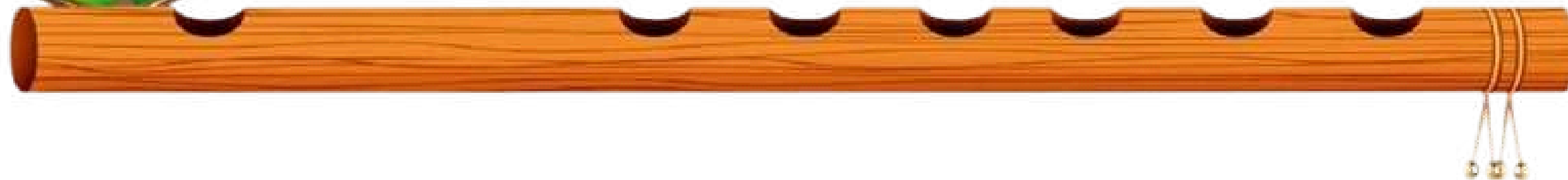

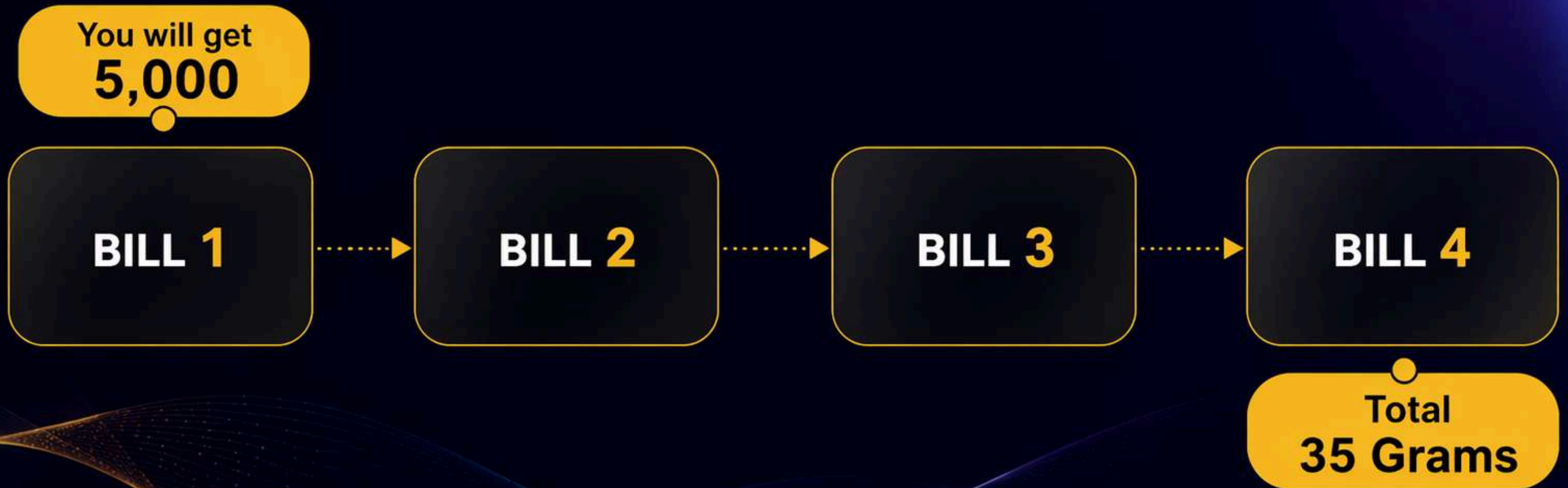

Auto Bill Queue System

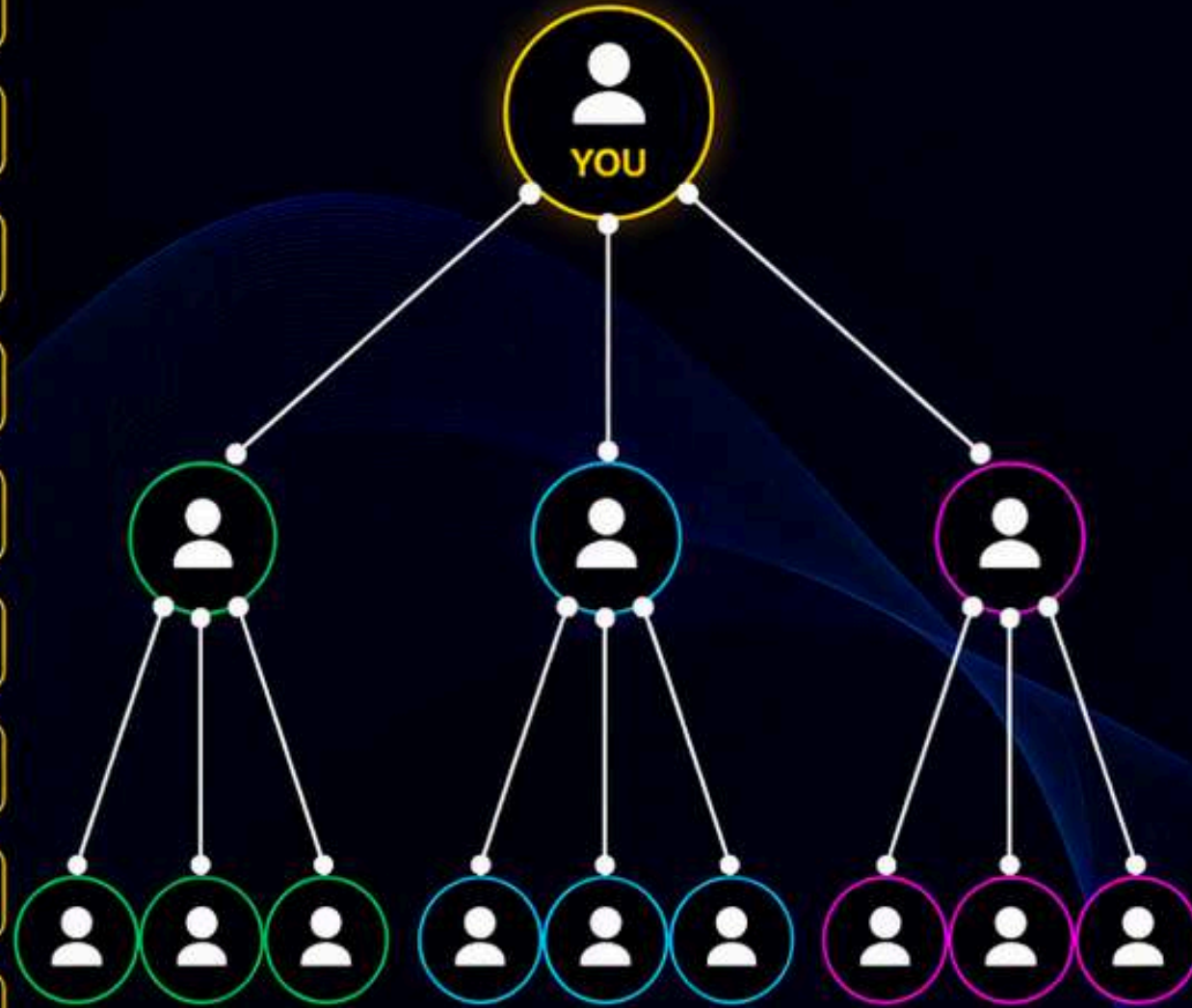
